Leasing / Lending

Leasing is the easiest and quickest method of raising finance, which use by every landlord. Before Apartlease, no one believes that the particle of their asset can be lease at any cost in the market.

Apartlease introduced the new leasing concept in October 2019. They have allowed a Landlord to lease a part of the property (apartment or house) at a particular period, and the landlord receives the total rent of the contracted period at discount rate.

Apartlease as a lessee and property has taken for beneficiary ownership, which means that the landlord must administrate the leased property and pay back half or agreed amount as a rent from the property on the lease term.

Avoiding the failure of monthly rent, the landlord provides a dated paycheck to the lessee on behalf of the tenant. Under beneficiary ownership, the landlord is a lessor as well as the administrator of the leased property.
